Earned Income and Exemption Eligibility

Exemption – Earned Income

Income assistance recipients (both employable and disabled persons) are eligible for the following earned income exemptions if:

- they have been receiving income assistance support for the one month immediately preceding the month for which the exemption is claimed, and,
- each person in the family unit is under 65 years of age

Exemption – Single Employable, Childless Couple, Dependent Child who is not a Full-time Student

Description	Treatment Prior April 1 st	Treatment After April 1 st
Employable single	No prior exemption	Up to \$ 200 Per Month
Employable childless couple, one-parent, two-parent family units, dependent child who is not a full-time student	No prior exemption	Up to \$ 200 Per Month Per Family Unit

Exemption – Single Parent Recipients with a Disabled Dependent

Description	Treatment Prior April 1 st	Treatment After April 1 st
Single parent unable to leave home for the purposes of employment due to caring for a: <ul style="list-style-type: none"> • disabled and dependent child • grandfathered COPH with a disability • foster child with a disability 	Up to \$ 300 Per Month Per Family Unit	Up to \$ 300 Per Month Per Family Unit

Exemption – Persons with Disabilities Recipients

Description	Treatment Prior April 1 st	Treatment After April 1 st
Single adult with PWD designation	Up to \$500 Per Month	Up to \$800 Per Month
Family unit where one adult has a PWD designation	Up to \$500 Per Month Per Family Unit	Up to \$1,000 Per Month Per Family Unit
Family unit where both adults have a PWD designation	Up to \$750 Per Month Per Family Unit	Up to \$1,600 Per Month Per Family Unit

Exemption – Persons with Persistent Multiple Barriers Recipient

Description	Treatment Prior April 1 st	Treatment After April 1 st
All categories with a PPMB designation	Up to \$500 Per Month	Up to \$500 Per Month
